

## **PART 1 - INTRODUCTORY PROVISIONS**

### **Short title**

- 1.1 This regulation may be cited as the Ticket Form Amending Regulation.

### **Application**

- 1.2 This regulation makes an amendment to the Compliance Notice and Ticket Regulation.

### **Definitions**

- 1.3 In this regulation,

“Compliance Notice and Ticket Regulation” means the Compliance Notice and Ticket Regulation UTR 18/2014.



## **PART 2 - REGULATION AMENDMENTS**

### **Compliance Notice and Ticket Regulation amendments**

- 2.1 The Compliance Notice and Ticket Regulation is amended by repealing Form EA-2 set out in Schedule 1 and replacing it with Appendix "A" to this regulation.






### **PART 3 - GENERAL PROVISIONS**

#### **Commencement**

- 3.1 This regulation comes into force on the date it is enacted.
